SCHOLARSHIP PROGRAM

RULES AND REGULATIONS

Following are the rules and regulations governing eligibility of recipients of the Scholarship Award of the Mortgage Bankers Association of St.Louis.

1. In order to be eligible, applicants must either be an employee or dependent of a St. Louis Mortgage Banker member and have graduated or be graduating from an accredited high school.
2. Applicants must rank in the upper 50 percent of their graduating class.
3. Scholarship will be awarded on the basis of:
 - a) Academic rank
 - b) Extra-curricular activities and leadership potential
 - c) Character references and other pertinent factors
4. Scholarship recipients must attend an accredited college or university on a full-time basis. College is defined to include junior college.
5. The MBA Scholarship is available for all fields of study and open to new applicants as well as previous recipients.
6. The award must be used within one year of the date issued or it will be forfeited.
7. The application will be reviewed by the Scholarship Committee.
8. Application deadline requires submissions be received by the 30th Day in April. The selected candidate will be notified of the committee's decision quickly.
